1. Introduction

This Notice sets out how MT Cold Storage Solutions Ltd (**MTCSS**) uses and protects any information that you give MTCSS when you use this website.

2. What we collect

We may collect the following information:

- Name and job title
- Contact information, including email address
- Demographic information such as postcode, preferences and interests

3. What we do with the information we gather

5. How we use Cookies

We use traffic log cookies to identify which pages are being used. This us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.
